- BROADCASTING AND BARGAINING: LABOR RELATIONS IN RADIO AND TELEVISION**, edited by *Allen E. Koenig*. Madison, Wisconsin: University of Wisconsin Press, 1970. Pp. xii, 344. Cloth: \$8.00. Subject: A treatment of the special nature of labor relations within broadcasting, divided into four parts: Radio and Television in Focus, Federal Action and Arbitration in Broadcasting, Problems in Labor in Broadcasting, and the Future of Broadcasting Labor Relations.
- COOPERATIVE LOBBYING—THE POWER OF PRESSURE**, by *Donald R. Hall*. Tucson, Arizona: The University of Arizona Press, 1970. Pp. xviii, 347. Paper: \$4.95. Subject: An examination of certain of the activities of one of the largest and most powerful of the Washington lobbies, the Chamber of Commerce of the United States.
- CORPORATE ACQUISITIONS AND MERGERS VOL. II**, by *Byron E. Fox and Eleanor M. Fox*. New York: Mathew Bender, 1970. Pp. xxviii, Loose Leaf Binder: \$52.00. Subject: The second volume of this treatise completes the comprehensive coverage of mergers and acquisitions. This volume covers, *inter alia*, critical financial, economic, and management problems that concern corporate officials and their attorneys, accountants, bankers, and advisers.
- EMPLOYMENT GRIEVANCES AND DISPUTES PROCEDURES IN BRITAIN**, by *P.L. Davies and K.W. Wedderburn*. Los Angeles, California: University of California Press, 1969. Pp. xvi, 301. Cloth: \$10.50. Subject: A look at the social background of British industrial relations from a legal viewpoint.
- ENGLISH AND AMERICAN JUDGES AS LAWMAKERS**, by *Louis L. Jaffe*. New York: Oxford University Press, 1970. Pp. x, 116. Cloth: \$3.50. Subject: Deals with the law-making function of judges in a democracy and contrasts English and American judges in their use of the judicial process.
- GI RIGHTS AND ARMY JUSTICE: THE DRAFTEE'S GUIDE TO MILITARY LIFE AND LAW**, by *Robert S. Rivkin*. New York: Grove Press, Inc., 1970. Pp. xxiii, 383. Paper: \$1.75. Subject: A well-organized handbook providing insight into the military system of justice.
- LAW AND THE BEHAVIORAL SCIENCES**, by *Lawrence M. Friedman and Stewart Macaulay*. New York: The Bobbs-Merrill Company, Inc., 1969. Pp. xxxv, 1059. Cloth: \$15.00. Part of the Legal Education Series, this course deals primarily with the ways in which the legal system affects society and in which society affects the legal system.
- MILITARY JUSTICE AND THE RIGHT TO COUNSEL**, by *S. Sidney Ulmer*. Lexington, Kentucky: The University Press of Kentucky, 1970. Pp. x, 115. Cloth: \$6.50. Subject: An exploration of the American serviceman's right to counsel, comparing such with a citizen's right to counsel in civil courts.
- OUR KIND OF OMBUDSMAN**, edited by *L. Harold Levinson*. Gainesville, Florida: Public Administration Clearing Service, University of Florida, 1970. Pp. v, 73. Paper: \$1.00. Subject: A Symposium on the Ombudsman, which was held in Florida in March 1969 under the joint sponsorship of the American Assembly and the University of Florida.
- TAX REFORM ACT OF 1969**, by *CCH Editorial Staff*. New York: Commerce Clearing House, Inc., 1969. Pp. 352. Paper: \$4.00. Subject: Containing the complete text of the Tax Reform Act of 1969, this reference source provides a quick comparison of the substantive law as it reads before and after amendment by this new Act. CCH's explanation of the new tax law is contained in another volume.

TRANSPORTATION LAW INSTITUTE 1968 OPERATING RIGHTS APPLICATIONS, *sponsored by the University of Denver College of Law and Motor Carrier Lawyers Association*. New York: The Bobbs-Merrill Company, Inc., 1969. Pp. xxi, 794. Cloth: \$15.00. Subject: The first of a series to be augmented annually, this edition focuses upon the preparation, protest, and trial of a motor carrier application before the ICC.

THE TRIAL RECORD OF DENMARK VESEY, *by John Oliver Killens*. Boston: Beacon Press, 1970. Pp. xxi, 175. Cloth: \$5.95. Subject: A complete republication of the official report of the trials of Sundry Negroes charged with attempting to raise an insurrection in the state of South Carolina by Lionel Kennedy and Thomas Parker. The record has been taken from the Harvard University copy of the report.

WORLD TRADE AND THE LAW OF GATT, *by John H. Jackson*. New York: The Bobbs-Merrill Company, Inc., 1969. Pp. xl, 948. Cloth: \$15.00. Subject: This work is based on a comprehensive and systematic examination of GATT documents and the voluminous preparatory work, as well as personal observation of GATT operations and extensive discussions with practitioners.
